5. Minutes / Action Items:

- Kerri Doleshall discussed repairs to the Weed and Pest County vehicle. Hofmeister moved to approve the repairs on the transfer
 case in the 2010 Ford pickup for the County Weed and Pest department; cost not to exceed \$2,500. Lock seconded, and the motion
 carried.
- Reviewed and answered questions regarding the monthly press release with Candie Fix and Jes-C French from the Haxtun and Holyoke newspapers. Pam Jensen to send the press release to the Holyoke radio station.
- Candie Fix discussed her concerns about the RV park during Fair and signs reserving spaces. Jensen to take issue to the Fair Board meeting in August.
- Bob Heldenbrand presented OEM monthly report. Discussed two grant applications for desk chairs and video equipment. Lock
 made a motion to approve a 2018 EMPG Special Project Grant Application to purchase eight (8) padded office desk chairs in the
 amount of \$1775.00. With a 50/50 grant match, the County's share would be \$887.50. Hofmeister seconded, and the motion carried.
- Joe Bellm discussed Fairground races for 2020; targeting eight (8) events.
- Bellm and Commissioners discussed recent excessive mileage on County's tractor and equipment that was used and returned muddy. Bellm to address issue with his team.
- Bellm and Commissioners discussed roof or building to house the Beer Garden. Commissioners to disuss ideas and cost, then
 present results to the Fair Board.
- Commissioners, Administrator and Deputy Administrator discussed controls, accounting, and obtaining department head's consent prior to using department head's budgeted funds.
- The board approved an Event Center Rental for Martha Olivas if she provides insurance to serve alcohol.
- Monica Perez and Elizabeth Cypers shared information on the upcoming 2020 Census.
- Ronnie Farmer presented the 2018 Audit and Cost Allocation Plan. Hofmeister moved to accept the 2018 audited financial statements and to certify the Cost Allocation Plan as presented. Lock seconded, and the motion carried.
- Deanna Webster discussed a possible Bible Rodeo camp event and facility costs in June 2020.
- The Commissioners consulted Al Wall on the next steps regarding the Amherst Weed & Junk complaint.
- · Commissioners followed up with Wall regarding the Red Flag Bill.

 Hofmeister seconded, and the motion carried.
- The board tabled the discussion for a replacement alarm system at the CSU extension office until they meet with Dennis Kaan, CSU Area Director, Agriculture & Business Management.

- Lock made a motion to sign the agreement with Sedgwick County for Mutual Aide Channel (MAC) Agreement. Hofmeister seconded, and the motion carried.
- Lock made a motion to approve the Retail Tavern Liquor license for Blisties. Hofmeister seconded, and the motion carried.
- Discussed and approved changing September 9th Commissioners' meeting to September 10th.
