Roberts moved to make no changes in the County Health Pool employee health care benefits for 2025. Timm seconded the motion, which carried unanimously.

Timm moved to authorize the Chairman to sign the Sales Tax Memorandum of Understanding for Control of Confidential Data appointing Andrew Nygaard as the 2025 county contact. Roberts seconded the motion, which carried unanimously.

Roberts moved to allow Road and Bridge Manager Kevin Scott to make an offer not to exceed \$20,000 for a 1979 International dump truck from Scott Rehfeld for use at the landfill. Timm seconded the motion, which carried unanimously.


