Nygaard gave the board an update on the pre-application meeting that he and Roberts had with National Renewable Solutions representatives Alex Ingulsrud and Mauli Sand regarding the Overland West wind project. Ingulsrud reported at the pre-application meeting that an Overland Energy West Citizens Board will be established in the future. Nygaard also reported on the upcoming Planning Commission hearing regarding the revised Phillips County zoning regulations. The hearing is scheduled for 8:00 p.m. on April 27, 2023, in the Biesemeier Room at the Phillips County Event Center.

Timm made a motion to authorize the chairman to sign a contract between Phillips County and Gary Engels for maintenance of the Phillips County Gun Range. Hofmeister seconded the motion. Motion carried unanimously. The contract will run from April 7, 2023 through April 6, 2024.

Hofmeister made a motion to approve the request from Maintenance Supervisor Lonny Vernon to allow Randy Owens to transfer from the Landfill Department to the Maintenance Department to fill the position that will be available June 30. He would be placed on GN40 Grade 20 Step 2. Timm seconded
