Phillips County Commissioner Meeting Minutes¹ August 9, 2023

The board held a work session with Road and Bridge Manager Mike Salyards and Assistant Road and Bridge Manager Kevin Scott prior to the meeting.

Call to order

Chairman Garold Roberts called the meeting of the Phillips County Commissioners to order and opened with the Pledge of Allegiance at 8:00 a.m. on August 9, 2023, at the County Courthouse in the Commissioner meeting room.

Approval of Consent Agenda

Timm made a motion to approve the consent agenda as presented. Hofmeister seconded the motion. Motion carried unanimously.

The board met with Karlie Sharp of IMEG Corp. on Teams to discuss Commissioner re-districting map scenarios.

Deputy Administrator/Planner Nygaard gave the board an update on broadband. Roberts gave the board an update on a conversation that he had with PCTelcom CEO/GM Vince Kropp.

Nygaard gave the board an update on the NE CO Revolving Loan Fund and the excessive force policy requirement for the Community Development Block Grant project.

Administrative Support Patrick Mitchell updated the board on American Rescue Plan Act funds.

Motions/ New Business

Hofmeister made a motion to adopt Resolution No. 2023-08-09-01 implementing an excessive force policy for Phillips County. The Resolution reads:

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PHILLIPS COUNTY, COLORADO, TO ADOPT AN EXCESSIVE FORCE POLICY

WHEREAS, Phillips County, Colorado, has made application for Community Development Block Grant (CDBG) Funds from the State of Colorado; and

WHEREAS, in accordance with Section 519 of Public Law 101-144 (the HUD Appropriations Act) certain statements of assurances and certifications are required; and

WHEREAS, the Armstrong/Walker "Excessive Force" Amendment, (P.L. 101-144) & Section 906 of Cranston-Gonzalez Affordable Housing Act of 1990 requires that a recipient of HUD funds adopt and enforce a policy prohibiting the use of excessive force by law enforcement agencies within their jurisdiction against individuals engaged in non-violent civil rights demonstrations; and

WHEREAS, the Armstrong/Walker "Excessive Force" Amendment, (P.L. 101-144) & Section 906 of Cranston-Gonzalez Affordable Housing Act of 1990 requires that a recipient of HUD funds adopt and enforce a policy enforcing applicable State and local laws against physically barring entrance to or exit from a facility or location that is the subject of such non-violent civil rights demonstration within its jurisdiction.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PHILLIPS COUNTY, COLORADO that pursuant to Phillips County being granted CDBG funds by the State, the Phillips County Commissioners by administrative act hereby adopt a statement of policy prohibiting the use of excessive force by law enforcement agencies within its jurisdiction against any individuals engaged in non-violent civil rights demonstrations and against physically barring entrance to or exit from a facility or location that is the subject of such non-violent civil rights demonstration within its jurisdiction.

Timm seconded the motion. Motion carried unanimously.

Roberts gave an update on the latest ambulance discussion at the most recent EMS Council meeting. The representatives who attended the meeting are recommending that the County double its annual contribution to the ambulance replacement fund.

Timm made a motion to approve the request from County Administrator Laura Schroetlin to move Sara Kumm to GN40 Grade 28 Step 2, effective August 1, 2023. Hofmeister seconded the motion. Motion carried unanimously.

Hofmeister made a motion to approve the request from Communications Center Director Sara Kumm to move Paolo Mallari to GN40 Grade 18 Step 2, effective August 1, 2023. Timm seconded the motion. Motion carried unanimously.

Timm made a motion to move County Administrator Laura Schroetlin to GN Grade 43 Step 5, effective August 1, 2023. Hofmeister seconded the motion. Motion carried unanimously.

Hofmeister made a motion to approve the request from County Administrator Laura Schroetlin to use American Rescue Plan Act funds to pay for training on mapping enhancements completed by IMEG Corp. in the amount of \$2,340.00. Timm seconded the motion. Motion carried unanimously.

Timm made a motion to approve the request from the Pheasants Forever to serve alcohol at its event on November 11, 2023, with the condition that a special events permit is obtained from the City of Holyoke. Hofmeister seconded the motion. Motion carried unanimously.

Adjournment

Chairman Roberts adjourned the meeting at 10:18 a.m.
