# Phillips County Commissioner Meeting Minutes<sup>1</sup> October 6, 2023

#### Call to order

Chairman Garold Roberts called the meeting of the Phillips County Commissioners to order and opened with the Pledge of Allegiance at 8:00 a.m. on Friday, October 6, 2023, at the County Courthouse in the Commissioner meeting room.

# **Appointments**

The board met with Event Center Reservationist regarding Event Center rental fees and Homesteader Park rentals.

## **Public Hearings**

Chairman Roberts opened the hearing at 9:04 a.m. to consider the subdivision exemption request from the Garry K. Haynes Family Trust, looking to divide a 10-acre parcel from a 128-acre parcel located in Section 31, Township 8 North, Range 47 West. Mike Salyards and Carl Wilcox, representing the Haxtun Gun Club, commented that trap league can sometimes run very late into the night. Max Haynes said any potential buyer will know that there is a gun club nearby that will continue to operate. Chairman Roberts, seeing no further public comments, closed the hearing at 9:13 a.m.

Chairman Roberts opened the hearing at 9:30 a.m. to consider the subdivision exemption requests from Rick Ensminger, looking to divide two 1-acre (+/-) parcels from a 2-acre parcel located in Section 29, Township 8 North, Range 47 West. Planner Nygaard commented that the buyer would have to go through the land use change permit process for the land to be used for commercial storage. He said the Town of Haxtun had also provided a letter saying that public water service is available for the tracts since they are under 2.5 acres each. Chairman Roberts, seeing no further public comments, closed the hearing at 9:36 a.m.

#### **Motions/New Business**

Timm made a motion to approve the subdivision exemption request submitted by the Garry K. Haynes Family Trust to divide a tract of approximately 10 acres from 128 acres in the NE 1/4 of Section 31, Township 8 North, Range 47 West. Hofmeister seconded the motion. Motion carried unanimously.

Hofmeister made a motion to approve the subdivision exemption requests submitted by Rick Ensminger to divide two 1-acre (+/-) parcels from a 2-acre parcel located in Section 29, Township 8 North, Range 47 West and sell one 1-acre tract to Brandon Blochowitz. Timm seconded the motion. Motion carried unanimously.

Hofmeister made a motion to correct the purchase price in a motion made at the meeting on September 28, 2023, to accept the bid from Platinum Technology for 8 Dell desktop computers, Model 7010 Optiplex, at a corrected cost of \$1,385 each plus a \$165/hour set up fee for a total cost of \$13,720. Timm seconded the motion. Motion carried unanimously.

The board approved the selling of arena lights through the sealed bid process.

Hofmeister made a motion to approve the request from Landfill Manager Bill Andrews to hire Isidro Juarez as a full-time Landfill Operator at GN40 Grade 15 Step 3, effective October 16, 2023. Timm seconded the motion. Motion carried unanimously.

Hofmeister made a motion to reappoint Bryan Pippett to a 2-year term on the Northeast Colorado Regional EMS/Trauma Advisory Council, expiring on June 30, 2025. Timm seconded the motion. Motion carried unanimously.

Timm made a motion to appoint Kelsey Garretson to the Phillips County Recreation District Board to fill the unexpired term of Richard Starkebaum ending on December 31, 2025. Hofmeister seconded the motion. Motion carried unanimously.

Timm made a motion to approve the request from Maintenance Supervisor Lonny Vernon to proceed with the seal coating project for the paved areas at the Fairgrounds, plus the Courthouse parking lot for a cost not to exceed \$36,000 to Bella Asphalt Maintenance LLC. Hofmeister seconded the motion. Motion carried unanimously.

Hofmeister shared with the board the changes to the CDOT Transportation Planning Regions, which do not affect Phillips County.
