# Phillips County Commissioner Meeting Minutes<sup>1</sup> January 17, 2025

The board discussed the controlled access doors for the Sheriff's Office.

### **Motions/New Business**

The board reviewed and discussed the CDOT HUTF annual report.

Roberts moved to approve the request from Sheriff Michael Beard to approve the estimate from Platinum Technology to install a controlled access door at the Sheriff's Office in the amount of \$7,682. Hofmeister seconded the motion, which carried unanimously.

Hofmeister moved to approve the annual CDOT/HUTF report as presented. Roberts seconded the motion, which carried unanimously.

Roberts moved to approve the request from County Clerk Beth Zilla to reclassify Mary Roberts to Senior Clerk and move her to GN Grade 24 Step 4, effective January 1, 2025. Hofmeister seconded the motion, which carried unanimously.

The board reviewed and discussed the appraisal of the Amherst Road and Bridge storage building. They tabled the discussion until more information can be obtained on the well and water supply.

Roberts moved to approve the request from Nici Akey and Economic Development to waive the fees for the Phillips County-Ogallala Commons E-Fair at the Phillips County Event Center on March 27, 2025. Hofmeister seconded the motion, which carried unanimously.

Hofmeister moved to approve the designation of Tom Timm as Phillips County's representative to the County Health Pool. Roberts seconded the motion, which carried unanimously.

Hofmeister moved to approve the designation of Andrew Nygaard as Phillips County's alternate representative to the County Health Pool. Roberts seconded the motion, which carried unanimously.

Roberts moved to approve the designation of Tom Timm to serve as proxy on behalf of Phillips County to the CCI Steering Committee during the 2025 session. Hofmeister seconded the motion, which carried unanimously.
