Timm moved to approve the BOC Pavilion Concessions agreement between the Holyoke Chamber of Commerce and Phillips County as presented. Roberts seconded. Motion carried 3-0.

Roberts moved to approve the request from Salyards to move Kevin Scott to RB Grade 34 Step 7 (\$59,925.11 annually, \$4,993.76 Monthly), effective January 1, 2022.

Timm moved to approve the request from Michael to forgive taxes, interest, and fees in the amount of \$211.05 on tax account R011055. Roberts seconded. Motion carried 3-0.

Gaskill discussed the open dispatcher position at the Communications Center and possible incentives to help with the hiring process. Additional information will be sought, and this will be addressed again at a later date.

The OEM 2022 EMPG-LEMS annual requirements were presented and reviewed.

Roberts moved to approve the 2022 EMPG-LEMS Part II Jurisdiction Information and Signatures paper. Timm seconded. Motion carried 3-0.

Timm moved to approve the 2022 EMPG-LEMS Part III Program Funding Application. Roberts seconded. Motion carried 3-0.
