County Attorney Tammy Kelley provided information on a subdivision exemption application.

Appointments

Michelle Harms met with the board to request that 4-way stop signs be installed at the intersection of County Road 35 and County Road 30 due to the increase of traffic after County Road 35 was opened to U.S. Highway 6. The board will talk to Road Supervisor Mike Salyards to get his recommendation.

The board met with Arlan Scholl from Scholl Oil, Maintenance Supervisor Dan Waln and Fairground Supervisor Lonny Vernon to discuss the sound system at the BOC Pavilion, the projection screens in the Heginbotham Hall at the Event Center and the installation of speakers outside the BOC Pavilion. The matter was tabled until Scholl provides an updated screen bid and more discussion takes place with the fair board and the livestock committee.

Waln and Vernon presented the board with bids on a snow pusher for the fairgrounds. Vernon was directed to get a bid from 21st Century as well. No action taken.

The board held a meeting via phone with Ed Glennemeier on his perspective of BST Racing wanting to put in a go-cart track at the fairgrounds arena.

The board met with Event Center Reservationist Carrie Anderson to discuss raising the rates of the Event Center rentals. The board agrees to change the day rate of the arena in the BOC Pavilion to \$315.00. and will revisit the remaining rates after more information is obtained.

Old Business

The board discussed the Regional Opioid Intergovernmental Agreement.

Motions/ New Business

The board discussed the vacancy on the West Cemetery District Board due to the passing of Brad Michael. Board will advertise for position in the Haxtun/Fleming Herald.

The board reviewed the Energy Impact Grant (EIAF-A00191) award of \$21,750. The Board will schedule a meeting with Sullivan, Green, and Seavy LLC to discuss their proposal that was submitted to complete the zoning regulations update.

Hofmeister made a motion to accept the recommendation of the Planning Commission to approve the subdivision exemption request submitted by Robert and Ronda Fetzer to sell 25.5 acres in the SW $\frac{1}{4}$ of Section 32-7-47 to an undetermined buyer. Roberts seconded the motion. Motion carried 3-0.

Roberts made a motion to accept the recommendation of the Planning Commission to approve the subdivision exemption request submitted by Christy L. Shafer to sell 4.02 acres in the NW $\frac{1}{4}$ of Section 17-7-43 to an undetermined buyer. Hofmeister seconded the motion. Motion carried 3-0.

The Commissioners decided to purchase Haxtun Lions Club Chuckwagon tickets at the Trail Boss Sponsor level in the amount of \$130. The purchase will be made with no county funds.
