Timm made a motion to approve the request from Maintenance Supervisor Lonny Vernon to move Brandon Markert to the newly approved classification of Assistant Maintenance Supervisor at GN40 Grade 25 Step 1, effective April 1, 2023. Hofmeister seconded the motion. Motion carried unanimously.

Hofmeister made a motion to approve the request from Administrator Laura Schroetlin to move Lonny Vernon to the newly approved classification for Maintenance Supervisor at GN40 Grade 28 Step 2, effective April 1, 2023. Timm seconded the motion. Motion carried unanimously.

Timm made a motion to approve the request from the Phillips County Fair Board to serve alcohol at its beer garden during the upcoming 2023 races at the Phillips County Raceway on April 28, May 26, June 30, August 25, and September 22, 2023, with the condition that a special events permit is obtained from the City of Holyoke. Hofmeister seconded the motion. Motion carried unanimously.

Hofmeister made a motion to approve the request from the Phillips County Fair Board to serve alcohol at its beer garden during the upcoming Phillips County Fair, July 26-July 30, 2023, with the condition that a special events permit is obtained from the City of Holyoke. Timm seconded the motion. Motion carried unanimously.

Timm made a motion to approve the request from County Clerk Beth Zilla to close the Clerk and Recorder office on April 12, 2023, to allow staff to attend motor vehicle training. Hofmeister seconded the motion. Motion carried unanimously.

Hofmeister made a motion to purchase 2,347 feet of tubing, well casing and caps for the fencing project at the fairgrounds at a cost not to exceed \$10,000 from A+ Fence Pipe Sales in Platteville. Timm seconded the motion. Motion carried unanimously.

Hofmeister made a motion to approve Timm Trucking to deliver the pipe for the fencing project at the fairgrounds for \$4 per running mile. Roberts seconded the motion. Motion carried 2-0, with Timm abstaining.
