# Phillips County Commissioner Meeting Minutes<sup>1</sup> February 28, 2022

#### Call to order

Chairman Timm called to order the meeting of the Phillips County Commissioners and opened with the Pledge of Allegiance at 9:00 A.M. on February 28, 2022, at the County Courthouse in the Commissioner Meeting room.

The board met with Department of Human Services Director Lori Lundgren to discuss some legislation changes and the Cost Allocation Contract.

## **Motions/ New Business**

Roberts made a motion to approve the revised effective date for new hire Michelle Sibbio to March 14, 2022. Hofmeister seconded the motion. Motion carried 3-0.

Roberts made a motion to approve the designation of Terry Hofmeister as Phillips County's representative to the County Health Pool. Timm seconded the motion. Motion carried 3-0.

Hofmeister made a motion to approve the request from Communication Center Director Kenny Gaskill to use American Recovery Plan Act funds to purchase one air purification unit for the Communication Center from ARYA Group in the amount of \$800.00 plus shipping. Roberts seconded the motion. Motion carried 3-0.

Hofmeister made a motion to approve the request from Holyoke Chamber of Commerce Director Holly Ferguson to refund all fees for the cancellation of their event that was scheduled for April 8-10, 2022. Roberts seconded the motion. Motion carried 3-0.

Roberts made a motion to approve the request from Maintenance Supervisor Dan Waln to hire Anabel Figuero Olivas as a part-time employee for the maintenance department, specifically as a custodian, effective March 1<sup>st</sup>, 2022. Hofmeister seconded the motion. Motion carried 3-0.

Hofmeister made a motion to approve the request from Road and Bridge Manager Mike Salyards to purchase a 6140 Rhino Ditch Mower from G&M Implement (now Redlund Equipment) for \$23,500.00. Roberts seconded the motion. Motion carried 3-0.

The board discussed the snow pushers for the maintenance department. The current one is being returned for a refund. The Maintenance department will solicit bid for a snow pusher that is the correct model for our skid steer. They will purchase the pullback attachment from our local Case dealership.

Hofmeister made a motion to approve the DHS Cost Allocation Contract with MGT of America Consulting, LLC for a one (1) year agreement beginning February 15, 2022, and expiring on February 15, 2023, at a total cost of \$5,200.00. Roberts seconded the motion. Motion carried 3-0.

Roberts made a motion to appoint Human Services Director Lori Lundgren as proxy to the 2022 Health and Human Services steering committee. Hofmeister seconded the motion. Motion carried 3-0.

The board discussed having all the Board Meetings Minutes digitized. County Clerk Beth is working on a Grant to help fund the project.

Hofmeister made a motion to go into executive session for discussion of a matter required to be kept confidential by the following federal or state law, rule, or regulation: under C.R.S. Section 24-6-402(4)(c). Roberts seconded the motion. Motion carried 3-0. The regular meeting recessed at 11:56 A.M. and reconvened at 12:09 P.M.

Chairman Timm stated that the additional participants in the executive session were: Laura Schroetlin, Terry Hofmeister, Garold Roberts and Nici Akey. Participants in the executive session were asked if they believed that any substantial discussion of any matters not included in the motion to go into executive session was in violation of the Open Meetings Law, to state their concerns for the record. No concerns were stated.

Roberts made a motion to waive the Buckle-up showmanship rental fee at the Pavilion from June 17<sup>th</sup> through the 19<sup>th</sup>. Hofmeister seconded the motion. Motion carried 3-0.
