Motions/New Business

The board agreed to move the county employee annual meeting from October 7, 2022, to October 18, 2022

Roberts shared Communications Center funding scenarios and comparisons with the board.

Hofmeister made a motion to accept the recommendation of the Planning Commission to approve the subdivision exemption request submitted by DTCT, LLC to sell 9.92 acres in the NE $\frac{1}{2}$, Section 21-T9N-R47W to Beau Starkebaum. Roberts seconded the motion. Motion carried unanimously.

Roberts made a motion to approve the request from Director of Human Services Lori Lundgren to hire Aleah Buccelli as a Caseworker II effective August 1, 2022. Hofmeister seconded the motion. Motion carried unanimously.

The board agreed that Communications Center Director Kenny Gaskill can advertise for an additional dispatcher.

County Treasurer Sharon Michael announced to the board that second tranche of American Recovery Plan Act funds in the amount of \$414,213 was deposited on June 30.

Hofmeister made a motion to approve the proposal submitted by Event Center Reservationist Carrie Anderson to change the rental agreement to include the kitchen for rentals of the Biesemeier Room and Heginbotham Hall at the Event Center as presented. Roberts seconded the motion. Motion carried unanimously.

CTSI Representative John Wagoner met with the board to share information for risk management with the Sheriff's Office.

The board approved the special rates for the RV Park at the fairgrounds during the week of the July 25 Phillips County Fair. The rates are \$12.50 for the first day and \$10 each day after that. The half rate prices are during Phillips County Fair only.

Roberts made a motion to approve the audit engagement agreement for fiscal year 2022 for an amount not to exceed \$19,000 as proposed by Ronnie Farmer of rfarmer LLC. Hofmeister seconded the motion. Motion carried unanimously.

The board met with CSU Extension Agent Jessie Stewart for her quarterly updates.

The board met with County Attorney Tammy Kelley regarding election issues.

Roberts made a motion to approve the request from Road and Bridge Manager Mike Salyards to contract with Scholl Oil and Transportation Co. for prepaid propane for the upcoming heating season September 2022 through May 2023. The contract is for 3,870 gallons at a maximum price of \$1.99 per gallon for a total contract amount of \$7,701.30. Hofmeister seconded the motion. Motion carried unanimously.

Hofmeister made a motion to opt out of the Opioid Settlement Fund Distribution, which will redirect the county's local share of opioid settlement funds to the region in which it is located. Roberts seconded the motion. Motion carried unanimously.

Hofmeister made a motion to approve the proposal from Platinum Technology to install a Compliance Standards and Reporting Manager system in the amount of \$695/month and a \$3,500 set-up fee. Roberts seconded the motion. Motion carried unanimously.
