

## PROJECT

Phillips County has constructed a new 250' x 350' covered pavilion and education center at the Phillips County Fairgrounds. Features of the Bank of Colorado Pavilion include:

- ◇ A large 160' x 200' mobile arena
- ◇ Pens for all animal species shown at the fair
- ◇ Bleachers for spectators
- ◇ Conference room
- ◇ Concession stand and kitchen
- ◇ Restrooms and showers

## HISTORY

The existing Phillips County fairgrounds exhibit buildings have served county residents since the late 1940's.

The west beef barn and the horse barn are well beyond their useful life. They, along with the sale arena, the scale house, and the metal structure used to fit cattle, were all removed to make space for the new BOC Pavilion.

## COMMUNITY SURVEY

In March of 2014, 71% of County respondents indicated that if funds are available, a new multi-purpose building should be built.

*The Bank of Colorado Pavilion and Education Center has unfolded as a place of prosperity and growth for the county that we call home.*

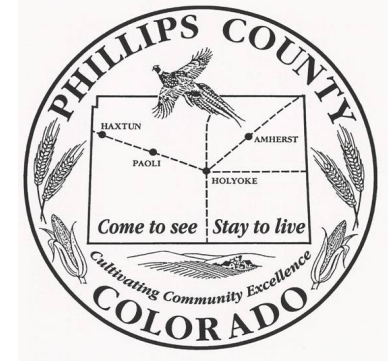
