**There are two races for Representative to the United States Congress - District 4 on this ballot. You may vote in both races.**

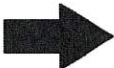

The winners of these primary election races will be the Republican Party's nominees in the November 2024 General Election.

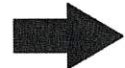
**Representative to the 119th United States Congress - District 4 - Full Term ending in January 2027**

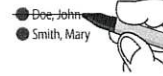
