Eligibility

- Must be eligible for VA care:
 - 1. An Honorable or General Under Honorable Conditions discharge from the military, with 24 consecutive months of active duty if enlisted after September 1980.

-or-

- 2. Eligibility as an OEF/OIF/OND Combat Veteran.
- 3. National Guard and Reservists may also qualify for VA benefits if they were called to active duty (other than for training) by Federal Order.
- Willingness to participate in all aspects of treatment and programming by adhering to all policies, rules and regulations of the Department of Veterans Affairs and treatment programs.
- Approved for release from incarceration and/or to attend treatment. The VA cannot provide custodial care.

Eligibility determination is based on each individual's service; we encourage all Veterans to apply for VA services

Some things the VJO CAN do:

- ♦ Serve Veterans of all eras
- Assess Veteran's healthcare needs and identify appropriate VA and non-VA services
- Refer and link Veterans to appropriate healthcare and/or treatment services
- Act as liaison to communicate essentials (attendance, progress, treatment testing, discharge plan) with justice system partners
- Assist Veterans with application process to treatment programs

Some things the VJO CAN'T do:

- Perform forensic psychiatric or psychological evaluations for Court
- Provide legal assistance
- Accept custody
- Pay or facilitate a bond
- Act as Co-Obligator for a bond
- Guarantee program/service acceptance
- Write lengthy Court reports, complete Diversion paperwork
- Advocate for legislation

Program Goals:

- **♦** Prevent homelessness
- Help veterans successfully transition back to the community
- ♦ Lower rate of return to jail or prison

The VA is committed to the principle that Veterans and their communities are better served by treatment services rather than incarceration, when the Veterans' nonviolent offenses are products of mental illness or substance abuse, a poor living environment or unemployment."

Veteran's Responsibility:

- ♦ Complete all enrollment forms, follow treatment plan and rules of the Department of Veterans Affairs
- ♦ Follow area agency, state, or federal Department of Correction rules
